City of Riverside Business Tax License

All persons or companies conducting business in the City of Riverside are required to pay a business tax.

Riverside County Department of Environmental Health Forms for Food and Beverage Vendors

The Chili Cook-off & Car/Cycle Show is a sanctioned community event approved by the Environmental Health Department. Temporary food facilities will be inspected on the day of the event, and throughout the event as needed, to check compliance with all applicable state and local requirements.

Riverside City Fire Department

Concession stands or vendors with cooking operations that include deep fat fryers shall provide a Class K wet chemical extinguisher. A minimum 2A:10BC fire extinguisher shall also be provided. Each generator or generator area shall be provided with at least one fire extinguisher with a rating of not less than 2A:10BC.

Refundable Cleaning Deposit for Food and Beverage Vendors

A \$200 refundable cleaning deposit is required from all food and beverage vendors. The deposit must be submitted as a separate check payment from other vendor fees. Inspections will be conducted at the end of the event. Deposit checks will be mailed within thirty (30) business days after the event.

Payment

Accepted forms of payment for vendor fees are cash, checks, money orders, and credit/debit cards. Credit/debit card payments will be processed via PayPal Invoice and require an email address; a PayPal account is not required. Refundable cleaning deposits must be paid by check. The Undersigned acknowledges, understands and agrees that the releases are not responsible and assumes no risk for any damage to or for lost or stolen personal property (including all artwork) of the undersigned. The Undersigned acknowledges, understands and assumes the risks, if any, arising from the conditions of the various event facilities, grounds and parking lots; and acknowledges and understands that this waiver includes, but is not limited to, any action or cause of action arising from (1) the performance, or failure to perform, maintenance, inspection, supervision, control or security of said areas, (2) for the failure to warn of dangerous conditions as existing on/or near said locations, or (3) for any action by the spectators or (4) for negligent supervision of, spectators, or (5) for any hidden, latent or obvious defects or dangerous conditions existing on/or near said locations.

It is the goal of the Arlington Business Partnership to avoid multiple vendors selling the same/similar item; however, there may be some exceptions to this rule.

THIS IS A RAIN OR SHINE EVENT. REFUNDS WILL NOT BE GRANTED

Applicant hereby agrees to the following terms and conditions:

1. Applicant shall furnish their own equipment including tents, tables, chairs, etc.
2. Applicant will be set up and ready for applicable inspections by 8:30 a.m.
3. Applicant will submit full payment with this application. Food/Beverage vendors shall also include a separate payment of \$200 for the refundable cleaning deposit.
4. Food/Beverage, retail, and artisan vendors shall hold a valid City of Riverside business tax license. If applicable, applicant will purchase a one-day business license.
5. Applicant is to provide their own electricity and/or water.
6. Generators must be QUIET, in good working condition, and accompanied by a certified fire extinguisher.
7. Propane tanks are to be placed outside of booth, safely secured away from walkways.
8. **FOOD /BEVERAGE VENDOR** should review the Temporary Event Operators Guide available online at www.rivcoeh.org/Programs/TFF. After reviewing the guide, please submit a Community Event Temporary Food Facility Operator's Agreement Form and if applicable, a Kitchen Agreement Letter. 9. **FOOD /BEVERAGE VENDOR** must bring a certified ABC Dry Chemical 2A:10B:C Multi-Purpose Fire Extinguisher per Riverside City Fire Code: CFC 904.115.2 & 906. If using a fryer, vendor must also have a Class K Fire Extinguisher.
10. Signage visible to the public should be clean and professional.
11. Applicant shall only sell/distribute items listed on this application.
12. ABP is not responsible for any loss of revenue or product if applicant's booth is shut down for any reason including, but not limited to non-compliance, health inspection violations, fire code/safety violations, incomplete vendor application, missing business tax license, etc.
13. If any of the abovementioned terms and conditions are violated, this application will be terminated, and applicant forfeits any fees paid.
